Barbara Dunlap read the Sewer Committee Bills. Douglas Robbins made a motion to gave the Mayor the authority to terminate the present sewer contract with 90 days' notice with South Pymatuning. Council also tabled Larry McKnight time sheet for work done in South Pymatuning. This motion was seconded by Russell Shaffer a roll call vote taken James Carucci-yes, Russell Shaffer-yes, Donna Lapikas-yes, Lee Loutzenhiser-yes, Patti LaRocca-yes and Douglas Robbins-yes. Douglas Robbins made a motion to accept the bills as read. Russell Shaffer seconded the motion and the motion passed with all voting yes.

Douglas Robbins reported damage to the playground equipment in the park. Mr. Robbins called police and filed report. Gregory Lengyel is to inspect all the playground equipment for any other damage.

Patti LaRocca made a motion to accept the police report. Donna Lapikas seconded the motion and the motion passed with all present voting yes.

Douglas Robbins made a motion to purchase a new vacuum cleaner for the hall with the cost not to exceed \$200.00. The motion was seconded by Russell Shaffer a roll call vote taken James Carucci-yes, Russell Shaffer-yes, Donna Lapikas-yes, Lee Loutzenhiser-yes, Patti LaRocca-yes and Douglas Robbins-yes.

James Carucci read the Payroll Distribution, General Fund Distribution and the State Liquid Fuels Distribution reports. Donna Lapikas made a motion to pay the bills as read. The motion was seconded by Russell Shaffer and passed with all voting yes.

James Carucci made a motion to adjourn. Motion was seconded by Douglas Robbins with all present voting yes.
