Minutes of the Clark Borough meeting January 5, 2021 6:00PM

The meeting of the Clark borough council was called to order by counsel Present Jim Carucci who led in the pledge to the flag on Tuesday, January 5, 2020 at 6 PM. Others in attendance were Maryjo Harakal, Doug Robbins, Clark Eberhart Larry McKnight, Cameron McConahy, Henri Frei, Attorney Bill Madden, Ron Sanford, Jim Miller and Monica Simko.

There were no visitors in attendance.

Doug Robbins made a motion to except the minutes as written. The motion was seconded by Cameron McConahy and passed with all voting yes except for Henry Frei who abstained from the vote.

Jim Carucci read the Treasurer's Report for the Month of January. Cameron McConahy made a motion to accept and was seconded by Henry Frei passing with all voting yes.

New Business

Mayor Maryjo Harakal announced the 2021 Municipal Elections are this year and the following seats are up for re-election: 4 Councilmen, Mayor as well as the Tax Collector and Constable.

Henry Frei and Jim Carucci signed the subdivision plan for Lang/Nickel properties.

Hermitage Police CIRT/MOU Resolution was signed by council.

Correspondence

Mayor Maryjo Harakal read the correspondence from December and left it on the table for review.

Mayor Maryjo Harakal read Police Report for November 2020. Doug Robbins made a motion to accept which was seconded by Clark Eberhart and passed with all voting yes.

Cameron McConahy read Fire Report for December 2020. Cameron also made a motion to accept which was seconded by Jim Carucci and passed with all voting yes.

Clark Eberhart read the sewer bills for the month of January. Clark also made a motion to pay as read with a second from Doug Robbins and passed with all voting yes.

Clark Eberhart read a letter from Lakeside Acres stating that a 6" pvc lateral has been installed and the project is complete. Larry McKnight stated that once the Planning Commission put their approval to it then council can vote on the permanent occupancy permit. Clark Eberhart is to call Winslow Engineering regarding metering the building for sewer EDU's.

Doug Robbins stated that the ceiling in the social hall has been leaking. He and Jim Miller are going to put flashing on the roof to stop the leak. Doug Robbins also stated that he will be purchasing ceiling tiles soon.

Jim Miller stated that a street light is out and needs replaced and that he needs a new bottle jack for when he has to work on the trucks.

Cameron McConahy stated that a resident on Nora Street requested a speed limit sign be put up for Northbound traffic. The resident had addressed the speeding driver and they said that it was not posted. Larry McKnight stated that there should already be an ordinance on file for speed limits in the borough, but if not, one would need to be enacted.

The Audit of 2020 is set for February 18th and March 15th – 16th.

New Bidding Thresholds for 2021 are presented.

A Notice from Crooked Creek Dam was read.

Richardson Inspections submitted 2021 rates showing no increases.

The CARES Act agreement was presented and complete.
