During discussions with Ken Mattocks regarding the stormwater easement, Ken asked if the borough would share the cost of a fence to close off his property from the park to keep the public off his property for safety reasons.

Monica has reached out the gWorks for multiple updates. There has been no progress for onboarding. Monica is to send the contract to the Solicitor for review to see if we can request a refund.

Officials & Committees:

Sewer:

Clark Eberhart read the Sewer bills for the month of July. Clark Eberhart made a motion to pay sewer bills as read. The motion was seconded by Jason Engstrom and passed with all present voting yes.

Fire:

Alesha Culp read the Fire Report for the Month of June. Doug Robbins made a motion to accept the Fire report as read. The motion was seconded by Jason Engstrom and passed with all present voting yes.

Police:

Highways:

Chief Piccirillo asked if the new light at Route 18. Council stated that yes, that is where it was meant to be placed. The discussion of signage came up and that there is not an ordinance required for placing new signs. Jim Carucci made a motion to acquire overhead signs that say no left turns and no u-turns for both north and south directions. The motion was seconded by Alesha Culp and passed with a roll call vote of Jim Carucci – Yes, Doug Robbins - Yes, Clark Eberhart – Yes, Jason Engstrom – Yes, Carol Houck – Yes, Alesha Culp – Yes.

Building, Parks and Recreation:

Gregg Sanford advised council that the downspout on the north west side of the building that is plugged up. Doug Robbins stated that he will talk with Jim Miller to get the issue resolved.

Gregg Sanford also asked if there is a timer on the back lot lights because he noticed that they turn off around 12am and them slowly come back on. Council advised, not to their knowledge.
